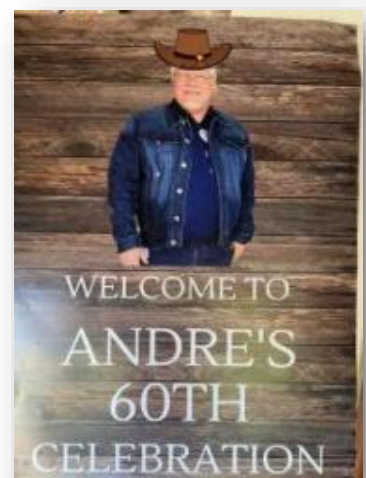

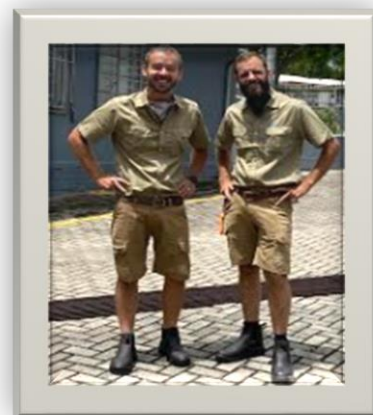

TAX SUBMISSION - 2020

Some Important Information from our Tax Division

Please remember to submit your Income Tax Return for the 2020 tax year and any outstanding Tax Returns, as SARS started to penalize clients for late submission of the 2020 Tax Return. Cut-off date was the 19th of February 2020, any returns submitted after penalties will be imposed. Please see below fixed rate on penalties;

<u>Annual Income</u>	<u>Penalty</u>
If your annual Income is between 0 - 250 000	250 per month
If your annual income is 250 001 - 500 000	500 per month
If your annual income is over 500 001 - 1 000 000	1 000 per month
If your annual income is over 1 000 001 - 5 000 000	2 000 per month
If your annual income is over 5 000 001 - 10 000 000	4 000 per month
If your annual income is over 10 000 000 - 50 000 000	8 000 per month
If your annual income is above 50 000 000	16 000 per month

Please remember these penalties are charged per month per return outstanding.

I would also like to inform clients to keep all proof of payments made on invoices and cards payments for personal and business purchases.
